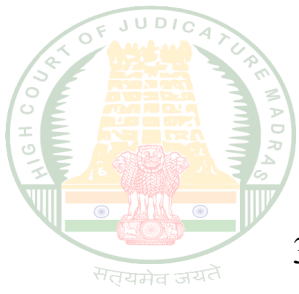

ORDER

This Criminal Original Petition has been filed by the petitioner/A9, who was arrested and remanded to judicial custody on 31.01.2025, seeking bail in Crime No.37 of 2025 registered for the offence under Section 8(c) r/w.22(b) and 25 of the NDPS Act, 1985 @ u/s.8(c), r/w.22(b), 25 and 29(1) of the NDPS Act, 1985.

2.The case of the prosecution is that on secret information, the respondent found A1 & A2 in possession of 1.82 grams of Cocaine, on their confession A9, who is the petitioner herein was implicated as accused in this case.



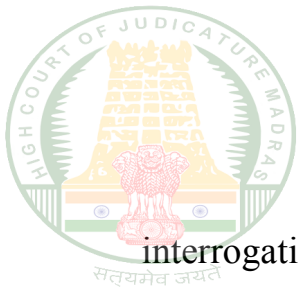

3.Learned counsel appearing for the petitioner submitted that the petitioner is an innocent person and he has been falsely implicated in this case based on the confession statement of main accused. He also submitted that the petitioner is in custody from 31.01.2025 and he is ready to abide by any stringent conditions that may be imposed by this Court. Hence, he prayed for grant of bail to the petitioner.

4.Learned Government Advocate (Crl.Side) appearing for the respondent police, while opposing for grant of bail to the petitioner, reiterated the prosecution case. The learned Government Advocate further submitted that no recovery has been made from the petitioner and that there are no previous cases against the petitioner.

5.Heard the learned counsel appearing for the petitioner and the learned Government Advocate (Crl. Side) for the respondent Police and perused the materials available on record including the counter affidavit of the respondent.

6.The petitioner was implicated on the confession of the co-accused and no recovery was made from the petitioner. Admittedly there is no other material connecting the petitioner with the other accused, who were in possession of the contraband. The petitioner has no bad antecedents. Hence considering the nature of allegations, period of incarceration undergone by the petitioner, and the aforesaid facts, and since further custody is not required for the purpose of

interrogation, this Court is inclined to grant bail to the petitioner with certain conditions.

7. Accordingly, the petitioner is ordered to be released on bail on his executing a bond for a sum of **Rs.15,000/- (Rupees Fifteen Thousand only)** with **two sureties**, each for a like sum to the satisfaction of the Principal Special Court for EC & NDPS Act, Chennai, and on further conditions that:

[a] the sureties shall affix their photographs and Left Thumb Impression in the surety bond and the Magistrate may obtain a copy of their Aadhar card or Bank pass Book to ensure their identity;

[b] the petitioner shall report before the respondent Police, everyday at 10.30 a.m., until further orders;

[c] the petitioner shall not abscond either during investigation or trial;

[d] the petitioner shall not tamper with evidence or witness either during investigation or trial;

[e] On breach of any of the aforesaid conditions, the learned Magistrate/Trial Court is entitled to take appropriate action against the petitioner in accordance with law as if the conditions have been imposed and the petitioner released on bail by the learned Magistrate/Trial Court himself as laid down by the Hon'ble Supreme Court in ***P.K.Shaji vs. State of Kerala [(2005)AIR SCW 5560]***;

[f] If the accused thereafter absconds, a fresh FIR can be registered under Section 269 of B.N.S.
