No.086, Natham Medu Village, Thiruvallur Taluk and District.

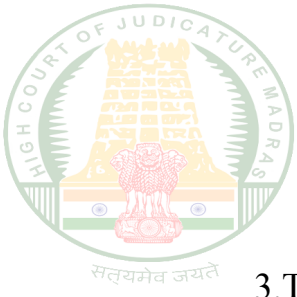
