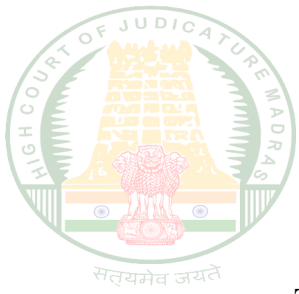

ORDER

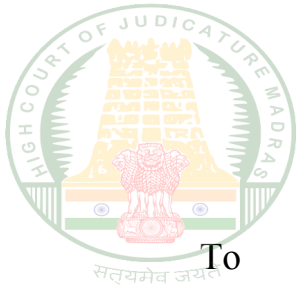

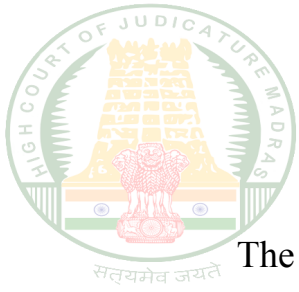
