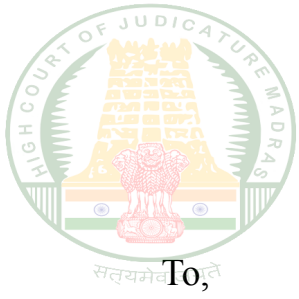
4. Being satisfied with the reasons stated in the affidavit filed in support of the petition, the delay stands condoned and the petition is ordered.
