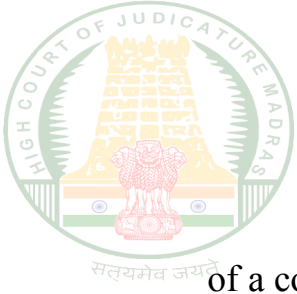

This Writ Petition has been filed by the petitioner in the nature of a Mandamus, seeking a direction against the respondents to pay interest for the belated payment of his terminal benefit namely Encashment of Leaves. The petitioner had given a representation on 29.02.2024.

2. In the affidavit filed in support of the writ petition, it is stated that the petitioner was working as a Senior Trades man in the respondent Transport Corporation and retired from service upon attaining the age of superannuation on 30.04.2023. According to the petitioner, the terminal benefits were disbursed with a delay and he now seeks interest for the delayed period.

3. A direction is therefore issued to the respondents to examine the petitioner's Service Register and verify the date when the amount was disbursed. If it is found that the amount was disbursed with delay, interest at the rate of 6% per annum shall be granted from the date of retirement until the actual date of disbursement. The entire exercise shall be completed within a period of four months from the date of receipt
