2. Learned Counsel appearing for Respondents 2 to 4 as Claimants in
the E.C Petition, objects to the petition to condone the delay on the ground



that it is a delaying tactics and therefore, prayed for dismissal of the petition.

3. On a query raised by this Court whether the Appellant herein as Respondent in E.C Petition had deposited the amount, learned Counsel for the Petitioner submits that a **sum of Rs.12,21,990/- had been deposited on the file of ' the Joint Commissioner of Labour ', Coimbatore.**

Joint Commissioner of Labour, Coimbatore.
