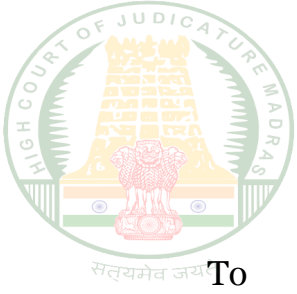
We clarify we have not made any observation on the merits of the matter.
