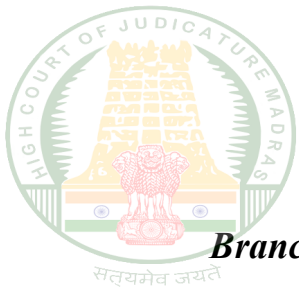

2. The learned counsel for the petitioner submitted that this Court, vide order dated 24.04.2024 has granted bail to the petitioner, that the petitioner hails from a poor family and is working as a Coolie, he is unable to deposit a sum of Rs.10,000/- and that he is still languishing in jail.
