Writ petition filed under Article 226 of Constitution of India for



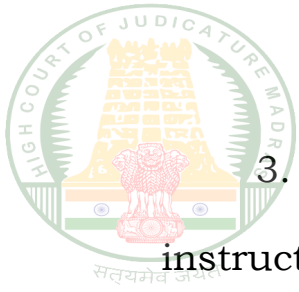

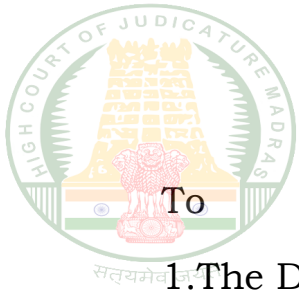
