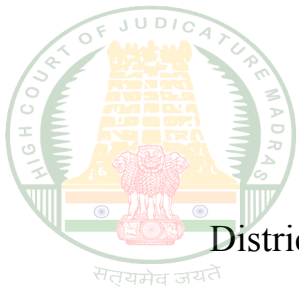

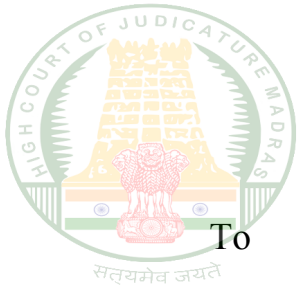
4. With the above direction, this Criminal Original Petition stands disposed of.
