ORDER

The petitioners, who apprehend arrest at the hands of the respondent police for the offences punishable under Section 296(b), 118(2), 351(3) of BNSS r/w 4 of TNPHW Act in Crime No.92 of 2025, seek anticipatory bail.

2. The case of the prosecution is that the petitioners attacked the defacto complainant with wooden rod and abused him in filthy language.

3. The learned counsel appearing for the petitioners submitted that the allegations are false; and that in any case, custodial interrogation is not required and sought for anticipatory bail to the petitioners.

4. Insofar as the petitioners 2 to 4 are concerned, the learned Government Advocate (Crl. Side) appearing for the respondent police, on instructions submitted that the petitioners 2 to 4 are not accused in this case. Hence, this criminal original petition is dismissed insofar as the petitioners 2 to 4.

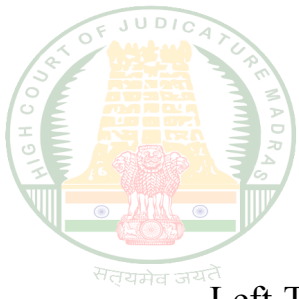
5. Insofar as the 1st petitioner is concerned, the learned Government Advocate (Crl. Side), while opposing the grant of anticipatory



bail, reiterated the prosecution case and on instructions submitted that the injured has been discharged from the hospital; that the petitioner has no bad antecedents.

6. Considering the nature of allegations, the fact that the injured has been discharged from the hospital, the 1st petitioner has no bad antecedents, and since, custodial interrogation of the 1st petitioner is not required for the purpose of investigation, this Court is inclined to grant anticipatory bail to the 1st petitioner with certain conditions.

7. Accordingly, the 1st petitioner is ordered to be released on bail in the event of arrest or on his appearance, within a period of fifteen days from the date on which the order copy is made ready, before the **Additional Mahila Court, Chengapattu**, on condition that the petitioner shall execute a bond for a sum of **Rs.10,000/- (Rupees Ten Thousand only)** with two sureties for a like sum to the satisfaction of the respondent police or the police officer who intends to arrest or to the satisfaction of the learned Magistrate concerned, failing which, the petition for anticipatory bail shall stand dismissed and on further condition that:

[a] the 1st petitioner and the sureties shall affix their photographs and Left Thumb Impression in the surety bond and the Magistrate may obtain a copy of their Aadhar card or Bank pass Book to ensure their identity.

[b] the 1st petitioner shall appear before the respondent police daily at 10.30 a.m., until further orders.

[c] the 1st petitioner shall not tamper with evidence or witness either during investigation or trial;

[d] the 1st petitioner shall not abscond either during investigation or trial.

[e] On breach of any of the aforesaid conditions, the learned Magistrate/Trial Court is entitled to take appropriate action against the Petitioners in accordance with law as if the conditions have been imposed and the Petitioners released on bail by the learned Magistrate/Trial Court himself as laid down by the Hon'ble Supreme Court in **P.K.Shaji vs. State of Kerala [(2005)AIR SCW 5560]**;

[f] If the accused thereafter absconds, a fresh FIR can be registered under Section 269 BNS.
