ORDER

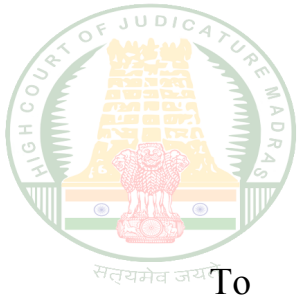
Assailing the impugned proceedings passed by the 2nd respondent dated 11.10.2018, the present Writ Petition has been filed.
