3. Earlier, the Government, has passed G.O.(2D) No.24, Labour and Employment (J1) Department, dated 02.03.2018 fixing the minimum wages. Thereafter, a Committee was appointed vide G.O.(D) No.458, Labour Welfare and Skill Development (J2) Department dated 27.06.2024 to review the minimum wages fixed in the said Government

Order and thereafter, in supersession of the said Government order G.O.(2D) No.24, Labour and Employment (J1) Department, dated 02.03.2018, the G.O.(2D) No.21 Labour Welfare and Skill Development (J1) Department dated 26.05.2025 has been passed, therefore, the prayer sought or in this Writ Petition has become infructuous.
