issuance of Writ of Mandamus, forbearing the respondents and their men, agents from collecting current consumption charges, demand charges and any arrears from the Petitioners HTSC No. 039094340375 till the entire outstanding dues of Rs.50,00,000/- payable to the petitioner along with interest towards refundable security deposit in account of the petitioner's Solar power Plant HTSC No. 069514420033 is paid or give adjustment in the current consumption charges payable by the Petitioner till the entire amount is adjusted.

ORDER

The grievance of the petitioner is that the petitioner set up Solar Power Plant and at that time, as per the requirement under the Rules, a sum of Rs.50,00,000/- was deposited by way of security deposit. Now the project is over and commissioned. Therefore, the respondent authorities are liable to refund the said amount to the petitioner. Instead of refund, they can also adjust against the outstanding dues in respect of the other high tension connection of the petitioner.

2. When the matter came up for admission, the learned counsel for the respondent Corporation would submit that it is true that the petitioner is entitled for refund and it can also be adjusted in the high tension connection dues.

3. In view thereof, this Writ Petition is disposed of with the following directions:

(i) The respondents are directed to refund the sum of Rs.50,00,000/- that was deposited by the petitioner as security deposit.

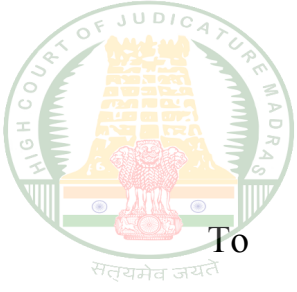
