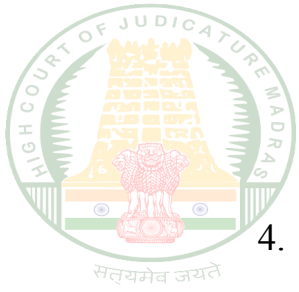

ORDER

This Civil Revision Petition has been filed by the petitioner seeking for a direction to the learned Principal District Judge, Dharmapuri to dispose the suit in O.S.No.197 of 2021.

2. It is the case of the petitioner that the petitioner/plaintiff had filed a suit seeking for a relief of delivery of possession of the suit schedule property and permanent injunction against the respondents/defendants in O.S.No.197 of 2021 before the Principal District Court at Dharmapuri. The respondents/defendants have also filed their written statement and the case now stands posted for framing of issues today (12.03.2025).
