ORDER

The District Revenue Officer, Villupuram is *suo motu* added as the 4th respondent in this writ petition.

2.This writ petition has been filed for issue of writ of mandamus directing the respondents to consider the representation made by the petitioner on 17.01.2025, wherein the petitioner has sought for the correction of the wrong



entry that was made during the UDR Scheme with respect to the subject property.

3. Heard Mr.K.Sathiyaraj, learned counsel appearing on behalf of the petitioner and Mr.S.Jayachandran, learned Government Advocate appearing on behalf of respondents 1 & 2.

4. The petitioner is claiming right and title over the property. According to the petitioner, during the UDR Scheme, the property was wrongly categorized as 'Odai' in the village revenue records. Therefore, the petitioner made a representation to the respondents on 17.01.2025 to carry out the necessary correction and to restore the original position. Since the same was not considered, the present writ petition has been filed before this Court.

5. Taking into consideration the facts and circumstances of the case and considering the materials placed before this Court, there shall be a direction to the impleaded 4th respondent to deal with the representation made by the



petitioner on 17.01.2025 on its own merits and in accordance with law and shall pass orders, within a period of twelve weeks from the date of receipt of copy of this order.

6.This writ petition is disposed of with the above directions. No Costs.
