2. Heard the learned counsel for the petitioner and the learned Government Advocate (Crl.Side) appearing for the first respondent and perused the materials available on record.

The petitioner is the complainant and the second respondent is the accused in S.T.C No. 2747 of 2023 on the file of the Fast Track Metropolitan Magistrate Court No. IV at George Town, Chennai, for the offence under Section 138 of the Negotiable Instruments Act. After receipt of summons, the second respondent did not appear before the Trial Court, and as such, the Trial Court issued a Bailable Warrant, and it is pending on the file of the first respondent.
