ORDER

2. When the matter came up for hearing, the learned Government Advocate appearing on behalf of the respondents 1 and 2, on written instructions, would submit that when the said appeal was taken up for consideration, the petitioner did not appear before the first respondent and even the communication sent was returned with an endorsement stating “no such person.”
