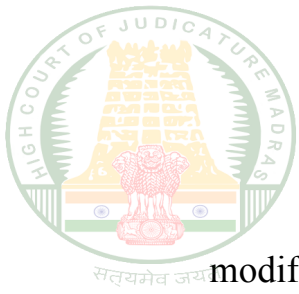

COMMON ORDER

2. It is seen from the grounds of revision filed by the petitioners, the civil revision petitions have been preferred by the petitioners challenging the order passed in I.A.Nos.44, 46 and 45 of 2016 in O.S.No.3265 of 2013. The number mentioned by the petitioners in their memorandum of ground is reflected in the order passed by this Court.
