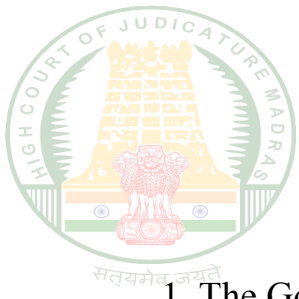
4. With the above direction, this Writ Petition is disposed of. No costs.
