3. It is learnt that the disciplinary proceedings have been initiated against the petitioner and it is over and orders are yet to be passed by the disciplinary authority. As the petitioner's entitlement to get retired from service would depend upon the orders going to be passed in the disciplinary proceedings initiated against her, the direction as sought by the petitioner at this juncture cannot be granted.
