3.The respondent may examine the service register of the petitioner and examine the eligibility of the petitioner to claim the aforesaid amount and if the petitioner is eligible, pay the same together interest at 6% per annum from the date of retirement till the date of actual disbursement. This exercise must be completed within a period of four months from the date of receipt of a copy of this order.

4. The writ petition stands disposed of. No costs.
