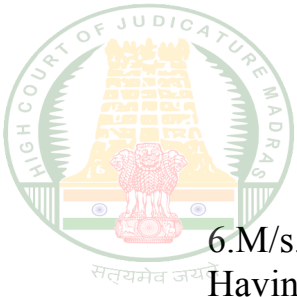

## **ORDER**

This writ petition has been filed seeking issuance of a writ of mandamus directing the respondents 2 to 4, particularly, the second respondent to deal with the representation made by the petitioner on 28.01.2025 wherein the petitioner is seeking for carrying out necessary corrections in the revenue records and for issuance of patta in the name of the petitioner.

2. Heard Mr.J.Ramesh, learned counsel for petitioner and Mr.P.Sathish, learned Additional Government Pleader appearing for respondents 1 to 4.

3. The specific case of the petitioner is that he was the owner of the property measuring an extent of 2.50 acres. Out of the total extent, the petitioner had sold 1.40 acres and he had retained 1.10 acres. However, patta has been issued in the name of the seventh respondent for an extent of 2.40 acres. Under such circumstances, the petitioner made a representation seeking for correction in the revenue records and for issuance of patta in the name of the petitioner for an extent of 1.10 acres.

Since the same was not considered, the present writ petition has been filed before this Court seeking for appropriate directions.

4. Taking into consideration the facts and circumstances of the case and considering the materials placed before this Court, there shall be a direction to the second respondent to deal with the petitioner's representation dated 28.01.2025 on its own merits and in accordance with law after affording opportunity to respondents 5 to 8 and final orders shall be passed within a period of eight (8) weeks from the date of receipt of a copy of this order.

This writ petition is disposed of with the above direction. No costs.
