This Criminal Original Petition has been filed seeking a direction to the Fast Track - I (Magistrate Level), Egmore, to forthwith number the case filed by the petitioner in S.T.C.(SR) No.71620 of 2024 and to proceed further in accordance with law.

2. Heard the learned counsel appearing for the petitioner and perused the available materials on record.

3. The petitioner is the complainant and the respondents are the accused for the offence punishable under Section 138 read with 141 of Negotiable Instruments Act, 1881. The petitioner lodged a complaint and the same was returned for want of corrections. Though the petitioner represented the same after complying with the corrections, the Trial Court failed to take the complaint on file so far.

4. In view of the above, the Fast Track-I (Magistrate Level), Egmore, is directed to take the complaint on file, if it is otherwise in order and record the sworn statement, within a period of two weeks from the date of receipt of a copy of this order.
