(Order of the Court was made by M.S.RAMESH, J.)

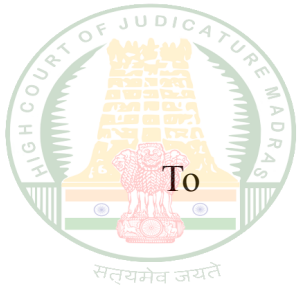
