ORDER

This writ petition is filed forbearing the 1st and 3rd respondents from taking any action against the petitioner on the basis of the representation of the 7th respondent dated 14.03.2016.

2. The seventh respondent is a counsel practising before this High Court. A perusal of the complaint shows that a serious allegation has been levelled against the petitioner. The prayer of the petitioner to restrain the official respondent from considering the representation given by the seventh respondent from proceeding further cannot be countenanced. As a matter of fact, the official respondent submits that the Vigilance and Anti Corruption proceedings have been initiated against the petitioner.
