ORDER

This Criminal Original Petition has been filed by the petitioner, who was arrested and remanded to judicial custody on 23.02.2025, seeking bail in Crime No.70 of 2025 registered for the offence under Sections 296(b), 118(1), 351(3) of BNS @ Sections 61(2), 296(b), 118(1), 351(3) of BNS, 2023.

2.It is the case of the prosecution that owing to previous enmity, the petitioner along with the other accused had abused the defacto complainant in filthy language, threatened him of dire consequences and assaulted him with knife on his back head and caused grievous injuries. Hence, the case.

3.The learned counsel for the petitioner would submit that the allegations are false; that the injured has been discharged from the hospital; that the petitioner is in custody from 23.02.2025 and hence further custody of the petitioner is not required and sought for bail.

4.Per contra, the learned Government Advocate (Crl. Side) reiterated the prosecution case and confirmed the fact that the injured has been discharged from the hospital.

5.Considering the nature of allegations, period of incarceration, the fact that the injured has been discharged from the hospital and since further custody of the petitioner is not required for the purpose of investigation, this Court is inclined to grant bail to the petitioner with certain conditions.

6.Accordingly, the petitioner is ordered to be released on bail on his executing a bond for a sum of **Rs.15,000/- (Rupees Fifteen Thousand only)** with **two sureties**, each for a like sum to the satisfaction of the **Judicial Magistrate, Denkanikottai**, and on further conditions that:

[a] the sureties shall affix their photographs and Left Thumb Impression in the surety bond and the Magistrate may obtain a copy of their Aadhar card or Bank pass Book to ensure their identity;

[b] the petitioner shall stay at Chennai and report before the **Flower Bazaar Police Station everyday at 10.30 a.m., until further orders.**

[c] the petitioner shall not abscond either during investigation or trial;

[d] the petitioner shall not tamper with evidence or witness either during investigation or trial;

[e] On breach of any of the aforesaid conditions, the learned Magistrate/Trial Court is entitled to take appropriate action against the petitioner in accordance with law as if the conditions have been imposed and the petitioner released on bail by the learned Magistrate/Trial Court himself as laid down by the Hon'ble Supreme Court in ***P.K.Shaji vs. State of Kerala [(2005)AIR SCW 5560]***;

[f] If the accused thereafter absconds, a fresh FIR can be registered under Section 269 B.N.S.
