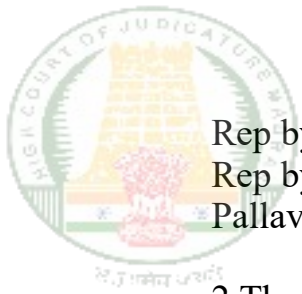
2. Recording the endorsement, the writ petition is dismissed as withdrawn. No costs. Consequently, connected miscellaneous petitions are closed.
