3. Learned Government Advocate appearing for respondents submitted that the petitioner has sought for transfer of patta in his name, whereas, the petitioner is having sisters and hence, the second respondent has not acted upon the OnLine application submitted by the petitioner.

In the considered view of this Court, if the second respondent wants to get any clarification from the petitioner, he can call the petitioner for enquiry and he can be asked to produce necessary documents and thereafter, the second respondent shall take a decision on the OnLine application submitted by the petitioner.
