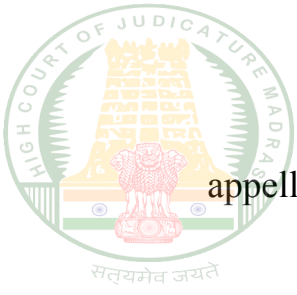

3. The abatement caused due to the death of the appellant is set aside and hence, C.M.P.No.10200 of 2022 is ordered as prayed for.

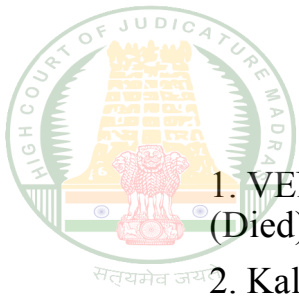
