In these two matters, the parties have approached this Court aggrieved by the fact that the site visit certificate was not issued.

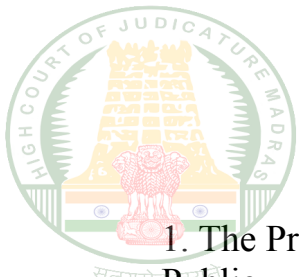
