## **ORDER**

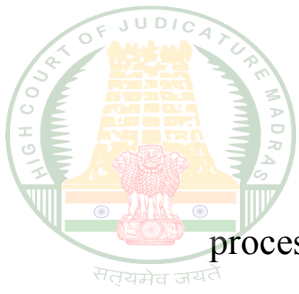

Based on the materials placed before this Court and on considering the submissions made by the learned Senior Counsel appearing for the petitioner, when the matter came up on 01.04.2025, this Court directed the learned Additional Government Pleader to take instructions. Accordingly, the matter was listed for hearing today.

4. Learned Additional Government Pleader, on instructions, submitted that the application submitted by the petitioner will be
