COMMON ORDER

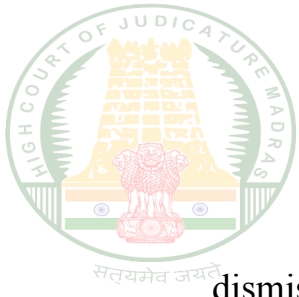

2. Heard the learned counsel appearing for the petitioners and the learned Government Advocate (Crl.Side) appearing for the respondent-Police and perused the materials available on record.

3. On a reading of F.I.R, it is seen that there are *prima facie* allegations levelled as against the petitioners. The grounds taken by the petitioners are nothing but defence and the same can be agitated only after completion of investigation and filing of final report by the Investigating agency before the trial Court.
