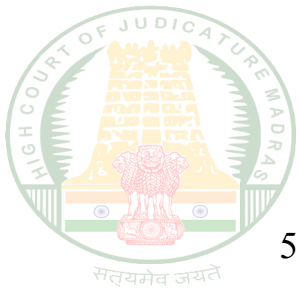
ORDER

WEB COPY This writ petition is filed to direct the second respondent to issue a legal heirship certificate to the petitioner in respect of the death of his father, namely *Ramalingam*.

2. According to the learned counsel appearing for the petitioner, there is no dispute regarding the legal heirs. An application has already been made, however the same is kept pending till date.

When the matter came up for admission, Mr.R.Sreedhar, the learned Additional Government Pleader appearing on behalf of the respondents, submitted that though a representation had initially been made, it can be seen that the petitioner has applied in the proper format. A notice of hearing was also issued on 04.03.2025, requesting the petitioner to approach the second respondent within seven days from the receipt of the communication.
