2. At the outset, this Court is of the view that the petitioner virtually seeks an injunction by way of a writ petition, which cannot be entertained. If in case any illegal activities take place in the guise of strike or if there is any disturbance caused to the petitioner Institute, the petitioner is at liberty to lodge a complaint with the respondent Police and the respondent police shall act on the complaint of the petitioner in accordance with law.

3. With these observations, this writ petition is closed. No costs. Consequently, connected miscellaneous petition is closed.
