2. The impugned order has been issued without notice to the petitioner without traversing through the facts of the case and the documents the impugned order is quashed and the matter is remitted back to the 3rd respondent for fresh consideration after due notice to the petitioner and giving him an opportunity of personal hearing. The impugned order shall be treated as a show cause notice and an explanation shall be submitted by the petitioner. Thereafter, within a period of 2 months, the 3rd respondent shall pass orders on merits and in accordance with law.

3. With the above direction, this writ petition is allowed. No costs.
