PRAYER Writ Petition filed under Article 226 of the Constitution of India for issuance of a Writ of Mandamus, directing the Second Respondent to dispose of the Petitioner application dated 07.08.2023 sent by registered post received by the second respondent on 08.08.2023 for enhanced compensation under section 3G(5) of the National Highways Act, 1956 as amended within time frame for the lands acquired in Survey No.5/2A2 measuring an extent of 42 Sq.mtrs at Vanagaram Village, Ambattur Taluk, Thiruvallur District.

ORDER

This writ petition has been filed for issue of writ of mandamus directing the 2nd respondent to pass orders in the petition filed by the petitioner under Section 3G(5) of the National Highways Act, 1956, within the time frame fixed by this Court.

2.The land belonging to the petitioner was acquired by the National Highways and the 3rd respondent conducted the enquiry and fixed the compensation. Not being



satisfied with the compensation fixed by the 3rd respondent, an appeal was filed before the 2nd respondent under Section 3G(5) of the National Highways Act, 1956.

Since the same was not considered, the present writ petition has been filed before this Court.

3. Taking into consideration the facts and circumstances of the case and the materials placed before this Court, there shall be a direction to the 2nd respondent to deal with the application submitted by the petitioner on 07.08.2024 after giving opportunity to the petitioner and the National Highways Authority of India and final orders shall be passed, within a period of twelve weeks from the date of receipt of copy of this order.

4. This writ petition is disposed of with the above directions. No Costs.
