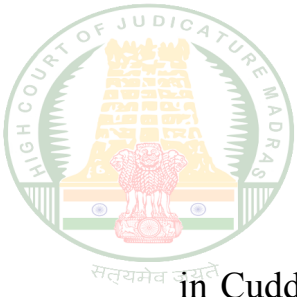

ORDER

The instant writ petition has been filed with a prayer for issuing a Mandamus to direct the first to third respondents herein to consider the request of the petitioners to transfer them from their present station to any of the vacancies in the post of Office Assistant to Cuddalore District.

2. The learned counsel for the petitioners would submit that they have given representations dated 12.02.2025 and 18.02.2025 seeking to consider the petitioners' transfer to any of the vacancies in the post of Office Assistant
