This Criminal Original Petition has been filed seeking a direction to the third respondent to execute the Non-Bailable warrant issued against the first respondent in STC No.128 of 2024 on the file of the Judicial Magistrate, Fast Track Court, Thiruthuraipoondi, Thiruvarur District.

2. Heard the learned counsel appearing for the petitioner and the learned Government Advocate (Crl.Side) appearing for the respondents 2 and 3. Perused the materials available on record.

The petitioner is the complainant in STC No.128 of 2024 on the file of the Judicial Magistrate, Fast Track Court, Thiruthuraipoondi, Thiruvarur District, filed against the first respondent for the offence punishable under Section 138 of the Negotiable Instruments Act. After receipt of the summons from the Trial Court, the first respondent failed to appear before the Trial Court and as such the Trial Court issued a Non-Bailable Warrant against the first respondent.
