2. When the matter came up for admission, Mr.J.Jai Venkatesh,

the learned counsel taking notice on behalf of the respondents would contend that even as per the petitioner is only the co-owner of the property in which case, the petitioner has to submit the no objection from the other co-owners.

3. The learned counsel for the petitioner in reply would submit that since the other co-owners are not cooperating, the petitioner has already submitted the indemnity bond. Therefore, the third respondent shall consider the same and process the application of the petitioner and pass final orders within a period of four weeks from the date of receipt of the web copy of the order, without waiting for the certified copy of the order.

4. With the above direction, this Writ Petition is disposed of. No costs.
