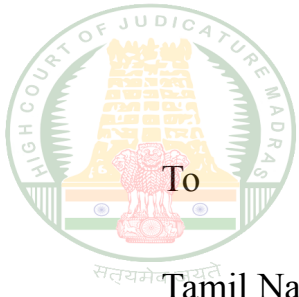
2. Recording the same, these writ petitions are closed as infructuous. No costs. Consequently, the connected miscellaneous petitions are closed.
