The petitioner may be permitted to withdraw this w.p with liberty to file PIL before this Hon'ble court.

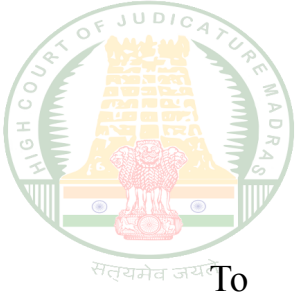
