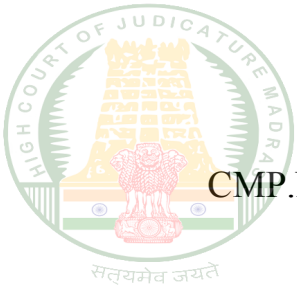
COMMON ORDER
