3. The case of the petitioners is that the subject property was assigned in their favour and they are in possession and enjoyment of the same. They made a representation seeking for patta which was not considered and hence, the present writ petitions have been filed before this Court.

4. When the matter was taken up for hearing today, the learned Additional Government Pleader produced the written instructions received from the second respondent. The second respondent has already
