ORDER

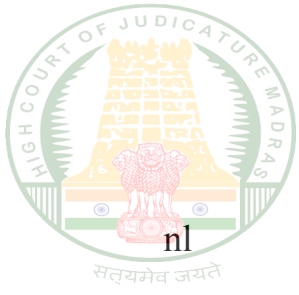
The writ petition has been filed in the nature of a mandamus seeking benefit of the wage settlement dated 04.01.2018 entered into under section 12(3) of the Industrial Disputes Act, 1947, commonly referred to as Section 13the wage settlement to be afforded to the petitioner also.

2. It is contended that the petitioner had retired from service on attaining the age of superintendent on 31.07.2017. Therefore, he claimed that the benefit of the settlement entered into on 04.01.2018 should also be paid to him.

The respondents may examine whether the petitioner is eligible for such benefit to be paid and if he is eligible pay the said amount to him. The petitioner is also entitled for interest at the rate of 6% per annum from the date of settlement till the date of disbursement. The entire exercise must be completed within a period of four months from the date of receipt of a copy of this order.

4. The writ petition stands disposed of. There shall be no order as to costs.
