3. The issue involved in the present writ petition is squarely covered by

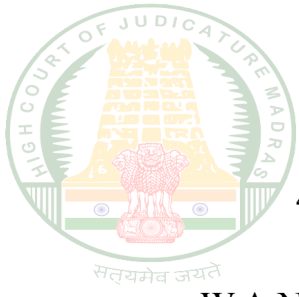
the decision of this Court in the case of *The Commissioner, Corporation of*
