ORDER

This writ of mandamus has been filed to direct the respondents 1 and 2 to consider the petitioner's representation dated 07.03.2023.

2. The grievance of the petitioner that she had already obtained a decree and judgment for permanent injunction in her favour in A.S.No.476 of 2005 on the file of VI Additional City Civil Court, Chennai. The third respondent herein, who is the petitioner's brother's wife, is allegedly causing disturbance. Hence, the petitioner seeks police protection.



3. Heard the learned Government Advocate (crl. Side) appearing for the respondents 1 and 2 and perused the materials available on record carefully.

4. Admittedly, the petitioner is having a decree in her favour. If there is any violation, she is at liberty to enforce the said decree in the manner known to law.
