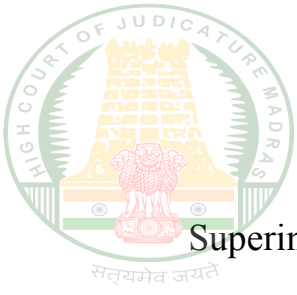
ORDER

WEB COPY This Criminal Original Petition has been filed for transfer of investigation in Crime No.403 of 2024 on the file of the Inspector of Police, R.S.Puram Police Station, Coimbatore City, Coimbatore District.

2. On the complaint lodged by the petitioner, the first respondent registered the FIR in Cr.No.403 of 2024 for the offences under Sections 406, 420 & 506(2) of I.P.C. However, the investigation is duly pending on the file of the respondent , as if the petitioner filed the petition for transfer of investigation.

3. The learned Government Advocate (Crl.side) on instructions would submit that almost entire investigation is completed.

4. Considering the facts and circumstances of this case, if the investigation is completed by the respondent police, final report is yet to be filed. Therefore, this Court is not inclined to transfer the investigation from the file of the respondent police herein. However, the respondent police is directed to complete the investigation within a period of eight weeks from the date of receipt of a copy of this order. The Deputy
