petitioner for the lease of Item No.1 of the Notification dated 29.12.2014 being the successful and higher bidder without insisting the Service Tax.

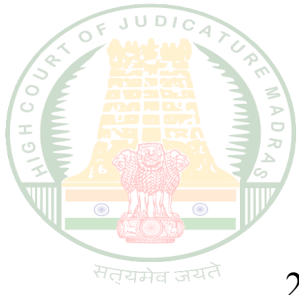
