4. Registry to number the writ petition, if it is otherwise in order, and be listed for admission on 08.04.2025.

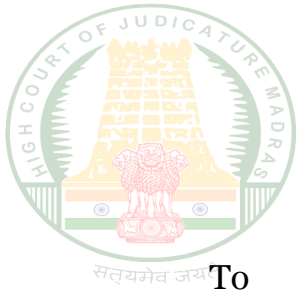
